On February 10th, 2009, the Negrini Family of Riverdale suffered a devastating house fire which claimed all of their possessions, as well as the lives of 9 of their 11 pets. After being rescued by the brave members of the Riverdale Fire Department, it was discovered that Judge had suffered third-degree burns on over 40 percent of his body. Judge has had extensive skin grafts, and has healed tremendously. The grafted skin is very delicate, and he will require additional small grafts until the healing process is complete. He has a wonderful temperament and an indomitable will to live, and his family is committed to helping him to the finish line on his journey to a full recovery.

Judge's Journey Motorcycle Run Participant Registration Form, Policy and Waiver

This is a Release/Indemnity Agreement – Please Read and Sign Below

By submitting the below completed and signed form, I hereby acknowledge the following:

Safety is the primary concern of Judge's Journey Motorcycle Charity Run. Please observe all federal, state and local laws, and ride safely and defensively. Judge's Journey requires that all participants wear helmets, as well as appropriate clothing, eyewear and footwear.

Registered vehicles carry motorcycle liability insurance coverage with minimum limits of \$15,000/\$30,000 bodily injury and \$10,000 property damage or statutory limit in the state of motorcycle registration. I acknowledge and understand that no insurance is available for coverage unless otherwise provided by private insurance obtained by the Undersigned.

Entry & Advertising Release:

In consideration of this entry, motorcycle owner and partner agree to permit Judge's Journey the use of their name and pictures, and pictures of their motorcycle for publicity advertising, and commercial purposes before, during and after the event and do hereby relinquish any rights whatsoever to any photos taken in connection with the event, and give permission to Judge's Journey to publish or sell or otherwise dispose of said photographs. All publicity and advertising rights are reserved by Judge's Journey.

Operation:

Event management reserves the right to restrict participants to acceptable behavior during all activities of Judge's Journey Charity Motorcycle Run. If for any reason a participant, his/her motorcycle, their appearance or conduct are deemed objectionable by event management, participant and motorcycle will be subject to eviction from the premises. This reservation includes persons, things, conduct, unnecessary tire spins, printed matter, or any act or item of poor conduct which the management considers objectionable to the event's well being. Any participant that appears to be under the influence of alcohol or drugs will be subject to eviction from the premises. In the case of eviction or restriction, Judge's Journey is not liable for refunding registration fees except at its own discretion.

Liability:

The undersigned acknowledges that Judge's Journey has no control, or ability to have control over, the acts of participants in the Charity Motorcycle Run sponsored by Judge's Journey. The undersigned is experienced in and familiar with the operation of motorcycles and fully understands the risks and dangers inherent in motorcycling. The undersigned is voluntarily participating in the event and expressly agrees to assume sole responsibility for the safe and successful operation of their motorcycle. The undersigned understands that they assume the entire risk of any accidents or personal injury, including death, which may result from participation in this event. The undersigned hereby agrees to release, acquit, discharge, indemnify, defend and hold Judge's Journey free and harmless from any and all liability, damage, injury (to persons or property) or otherwise that may be sustained or incurred by reason of, or during the undersigned's participation in this event.
